Memorandum of Undertaking between

## **DEPARTMENT OF SKILL DEVELOPMENT, J&K**

And

## INDIAN INSTITUTE OF TECHNOLOGY JAMMU

In an effort to revamp and rejuvenate the Polytechnic and ITI Sectors of Department of Skill Development, J&K and for intellectual cooperation scholarly exchange to enhance the skills and employability of the students and staff with exposure to latest technologies, **Department of Skill Development**, **J&K and IIT Jammu** agree to establish a program of exchange and collaboration on related matters of mutual interest that may emerge over time.

- The purpose of cooperation is Revamping and Rejuvenation of Polytechnic and ITI Sector in collaboration with IIT Jammu, to abolish unemployable and outdated Vocational Training Courses and to introduce new Area Specific Training Skills by keeping in view the demand of skills in forthcoming projects, such as Tunnels, Railways, Power Projects, Cold Storage/Refrigeration.
- Skill Development Centre (SDC) will be opened to enhance the skill of the students of Polytechnics and ITIs on the latest/ modern equipment in the relevant trades to final year/pass out students to

- enhance their employability. Tripartite MOU should be signed between Department of Skill Development, J&K and IIT Jammu with various private/ semi-government organisations under CSR obligations for enhancing the skill of Polytechnic/ITIs students.
- 3. ICICI has shown willingness to open a Skill Development Centre at Jammu and a tripartite MOU will be signed by Skill Development Department, J&K with ICICI and IIT Jammu. IIT Jammu will part some land to the ICICI for opening of Skill Development Centre to carry out the skill development activities for the final year and passout students of Polytechnic and ITI Sectors. Under Corporate Social responsibility obligation (CSR) ICICI will train the 50 candidates each from amongst the trainees which are in the final year or among passout from Polytechnics and ITIs from Jammu and Srinagar in the first phase i.e., 100 students in total will be trained every year in the relevant trades.
- 4. IIT Jammu will enhance the employability of pass-out trainees both from Polytechnic and ITI sector by providing hands on training on latest techniques and removing the skill gap to enhance the employability in the various sectors of J&K i/e. Railways in IRCON, Tunnels, Highway in IFCON, Power Projects, Cold Storage/ Refrigeration and operation and maintenance of heavy earth moving equipment such as JCBs, cranes, lifts and tunnelling equipment.
- 5. Government Polytechnic College Jammu has established Centre for Invention Innovation Incubation and Training (CIIIT) for providing training in the latest trends in the manufacturing industry conforming to Industry 4.0, with the help of Tata technologies Ltd Pune. IIT Jammu shall send the students of various streams to Centre for Invention, Innovation, Incubation and Training (CIIIT) Jammu for training of students in various courses and also for industrial training. The training shall be provided by the subject matter experts from Tata Technologies. The fee as approved by Higher authorities will be charged which will be provided/arranged by IIT Jammu. IIT Jammu

- shall bear the transportation charges for training and will support the promotional activities of CIIIT Jammu.
- 6. Well trained and qualified faculty of IIT Jammu will be provided for Guest/ Extension Lecturers, to organise symposia, conferences and Faculty Development Programmes (FDP) for Skill Improvement of trainers and faculty members of Polytechnics/ITIs.
- 7. Under Quality Improvement Programme (QIP), IIT Jammu will provide the opportunity to the Faculty of Polytechnics and ITIs to enhance their qualifications by providing admission in MTech, M.S Research and Ph.D. in various branches of Engineering on Part Time/Full Time with flexible timing on load sharing basis in parent Institute. The IIT Jammu will provide assistance in research work of the faculty/ students of the Polytechnics/ITI.
- 8. Both the parties will allow each to promote Institutional exchange by using their infrastructure and various Laboratories/ Workshops for Research work. IIT Jammu will adopt Govt. Polytechnic College Jammu in the first instance to start-with to develop, promote, organise Workshops, research programs.
- 9. IIT Jammu will assist in introducing the new area specialization contents in the syllabus of Polytechnics and ITIs and to abolish unemployable syllabus and unpopular and outdated courses. Faculty of IIT Jammu will provide assistance during the meetings of experts at Government Polytechnic College Jammu in near future for revision of the curriculum to update the syllabi of the different courses being run in the Polytechnic sector and to introduce the new Area Specific Training Skills.
- 10. Prior to the Initiation of any particular project of activity, the specific terms of cooperation and exchange for that project will be discussed and agreed upon in writing by the appropriate responsible representatives of both Institutions.

- 11. Both parties understand that all financial arrangements for specific exchange activities must be mutually agreed upon and will depend on the availability of funds. In addition, the scope of the activities will be subject to funds available at the Institutions for the type of collaboration undertaken and any financial assistance that may be obtained by either from external sources.
- 12. The parties agree that in the course of implementing this MOU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class national or ethnic origin or disability.
- 13. Amendments to this MOU may be made at any time after consultation and agreement between the two parties. Any such amendment must be in writing and signed by both parties.
- 14. The MOU will remain in force for a period of 05 years from the date it is fully executed. The MOU can also be suitably modified, as agreed to by both the parties, to reflect and increased scope, nature of engagement/ activities including financial commitments, if any. Prior to the expiration date, the MOU may be reviewed for possible renewal for a further 05 years per period.
